hereinafter referred to as "Client" or "Principal" – hereby **authorise Dárus Kincse 2001 Insurance Broker LLC** – hereinafter referred to as "broker-dealer" (office: H-1149 Budapest, Egressy út 60-68., tax ID number: 12666391-2-42, business registry number: 01-09-697501, and the Broker-Dealer's **Insurance Intermediary acting on the Broker-Dealer's behalf, named** (registration

number) , to manage my insurance affairs, to draft and establish my insurance contracts, to maintain my existing insurance contracts and to represent me in accordance with [Act LXXXVIII of 2014 on the Business of Insurance](#) (hereinafter referred to as "IA") and my wishes as set out below. **I voluntarily authorize the Broker-Dealer and its insurance intermediary to process my personal data which are necessary for managing my insurance affairs.**

**I. I authorize the Insurance Intermediary to provide the following insurance brokerage services** (please tick (v) applicable option/s)

- Collection and preparation of fee calculations:  requested  not requested

After establishing the insurance needs of the Principal, the Insurance Intermediary shall, using its professional expertise and experience, obtain an appropriate number of offers or make calculations based on valid fee tables of insurance companies that may be taken into consideration.

**II. Care of existing contracts**

The Principal states that it grants the insurance company an exemption to release information concerning its contracts and data to the Insurance Intermediary so that they may represent the Principal. The Principal further requests that the insurance company provide the Insurance Intermediary all information necessary for the Insurance Intermediary to manage the contracts concerned.

**The Principal states that it shall or has revoked or terminated insurance brokerage authorisations that they had issued earlier.**

**III. Declaration about direct marketing** (please tick (v) the applicable box below)



- This Contract of Agency must be signed by the CEO of Dárius Kincse 2001 LLC on behalf of our independent insurance brokerage company. This contract authorizes the Insurance Agent to represent the Client.
- The Broker-Dealer provides its insurance intermediaries with numbered licences with photo and makes their names available at <https://apps.mnb.hu/regiszter/> in the "Register of agents" as well as at the Broker Dealer's website: <https://dariuskincse.hu>.
- The present contract does not affect the insurance contract and the rights and obligations resulting from the insurance contract shall continue to apply to the subjects of the insurance contract. The Insurance Intermediary may not be deemed a representative of the insurance company, and thus may not make legal statements on behalf of insurance companies and has no authorisation for receipt with legal effect of legal statements concerning the insurance contracts of the Client, including receipt of legal statements regarding concluding or terminating the insurance contract. Legal statements of the Client to the insurance company shall come into legal effect upon receipt by an organisational unit of the insurance company. The Insurance Intermediary having been notified shall not be deemed equal to the insurance company having been notified!
- The collection of the insurance premium by the Insurance Intermediary shall not be deemed equal to the arrival of the premium to the account of the insurance company. The Insurance Intermediary shall forward, transfer, or pay the insurance premium to the insurance company using the standard payment slip of the insurance company. (See Section V of GTC)
- Dárius Kincse 2001 Insurance Broker LLC and its Insurance Intermediaries are obliged to keep confidential any information that they become aware of regarding the personal circumstances and financial situation of the Client, as well as information regarding the Client's contracts (insurance secrets). Dárius Kincse 2001 Insurance Broker LLC and its Insurance Intermediaries are obliged to observe the statutory provisions concerning insurance brokerage activities, with particular regard to the provisions on data processing and data protection, money laundering and the ethical codex. (See Section VIII of GTC).
- The termination of the authorisation shall only be deemed valid if it is made in writing at least 30 days before the anniversary of the insurance policy. It is deemed an exception to the above if the parties mutually agree to terminate the contract. To terminate a contract, an original, signed declaration must be verifiably sent to the other party. (See Section III of GTC)
- The parties agree that the Principal is obliged to notify the Insurance Agent fully and truthfully about any information, facts or changes that affect the insurance contract both during the period of offers being made and for the duration of the insurance contract. The Insurance Agent shall bear no indemnification liability for damages arising from the Principal's failure to do so. (See Section VI of GTC)
- No insurance brokerage fee is charged by the Insurance Agent for drafting insurance contracts and assistance in entering into such contracts. (See Section IV of GTC)
- Should the Principal terminate this authorisation without due cause after the Insurance Agent has completed their task of forwarding offers to the Client, the Insurance Agent may put in a claim for a commission for the tasks completed.
- The Insurance Agent does not bear liability for indemnification or related claims arising in connection with damage or loss events not covered by the standard contractual claims procedure of the insurance company.

- All matters not regulated by the present agreement shall be governed by the relevant provisions of the [Act LXXXVIII of 2014 on the Business of Insurance](#) and the Civil Code of Hungary.
- The Parties agree to try to settle any disputes about this contract by negotiations. In case they fail to do so, they stipulate the exclusive jurisdiction of the District Courts of Budapest. (See Section VII of GTC)
- **By signing this Contract of Agency, the Client acknowledges that they have read both pages of this Contract of Agency, they have properly indicated their requests and the data provided by them are accurate. They are aware of the fact, that providing false data is considered a failure to meet their obligation to provide information. The Broker-Dealer is not responsible for losses resulting from such a failure. The Client acknowledges that they have received a copy of the Contract of Agency.**
